SECRETARY'S REPORT



Dear Probians,

My Kind Greetings to all of you, your family members and friends.

Chennai and Tamilnadu experienced heavy rains in November. We had however

conducted our AGM at Kalyannagar Association on 27th Nov 2021, which is a dutybound subject under the Society's Act. Now that the situation has returned to normal, we are holding physical EC & monthly meetings after a lengthy break. However, we will still follow the strict SMS guidelines as the new variant Omicron is spreading throughout a few countries.

Our EC meeting for November 2021 was held at Gopalapuram Boys Higher Secondary School, Conron Smith Road, Chenna-600086 by 10.30 am on Saturday, the 20th Nov, 2021. Universal Prayer was rendered by Pbn Dr A. Bhavani. President Pbn B. Ranganathan welcomed the members and talked about the Late Pbn R. Ramakrishnan. He informed that the AGM notice with enclosures was already despatched and briefed on the preparations about the ensuing AGM like the Date, Venue, Gifts and Caterer for Breakfast and Lunch. Treasurer PF V. Balachander read the details of the Treasurer Report for October 2021. Members Directory updation was discussed among the members and the committee informed PF G. Sadagopan to complete as early as possible. Secretary Pbn M. Annadhurai proposed the vote of thanks.

Annual General Body Meeting (AGM) along with November month breakfast meeting was conducted at Kalyan Nagar Association, #29, West Circular Road, Mandavelipakkam, Chennai-600 028 on SATURDAY, 27th November 2021. The quorum to conduct the AGM was 1/3rd of the total 341 Members, i.e., 114 Members and for want of quorum, the Secretary announced adjournment of AGM by 30 minutes. During this adjournment time, the PPP TS. Ramaswamy, a Senior Advocate of Madras High Court with more than 50 years of legal practice, addressed the gathering on the topic "Omnipotent." He stressed that legally the law is clear and the AGM could be conducted even with 10 members if there is no quorum after the adjournment period. Probian NR Sampath gave a lecture on his "Unique experiences in his various foreign tours."

He recounted a visit to a 123 years old Vegetarian Restaurant, "Haus HILTL" in Zurich, Switzerland, where 160 vegetarian dishes were weighed before served. President Pbn B. Ranganathan, welcomed the gathering and thanked them for attending the AGM in spite of inclement weather. He spoke about the need for conducting the AGM due to the mandatory requirement to complete the AGM by Nov.,'21 to pass the Audited Financial Statements as the Income Tax return has to be filed before December 2021. He invited the IPP PF S. Gopalakrishnan to be seated on the dais as the Audited Financial Statements as on 31.03.21 were signed by him as the then President. He indicated that the Annual Book 2021 will be released in December and the EC has approved the names of (1) Kalaimamani Kizhambur Sankara Subramanian for Probus Award of Excellence and (2) Pbn Nirmala Thyagarajan Dr., Pbn Gopinathan V and Pn Mahadevan Mohan, Major Donor, for the Probus Recognition Award. Mementoes will be presented to Probians who completed 50 years of married life, 75, 80 and 90 years of age in the last two years. New Life Membership Certificates were given to Pbn AG Pranesan, Pbn B. Suresh Yagneshwar and Patron Certificate to PF R.Vivekanadan and all these members gave their self-introduction. IPP PF S. WORKSHOP ON SOCIAL SECURITY SCHEMES FOR FRAMING TN STATE POLICY FOR OLDER PERSONS, CONDUCTED BY J PAL AND TN SOCIAL WELFARE DEPT ON 30TH NOVEMBER 2021.

Director, Social Welfare and Women Empowerment organised a zoom meeting on 30.11.2021 inviting the following persons.

- 1. Tmt Girija Vaidyanathan I.A.S.(Retd), Ex Chief Secretary
- 2. Thiru M.Prashant Waadnere I.A.S. Addl. Secretary, Finance
- 3. Thiru Venkatachalam I.A.S. Revenue Administration
- 4. Thiru Elango I.A.S.
- 5. **Thiru Rajasekaran** President, FOSCATAN
- 6. Thiru Capt. Dr. M. Singaraja Senior Citizen Bureau
- 7. Thiru S. Ramalingam Senior Citizen Council, Tenkasi
- 8. Thiru R. T. Namasivayam Probus Club of Chennai

A presentation was made on the survey made on senior citizens of Tamilnadu. Our Senior Members were then asked to present our views on Social Security Schemes to be included in the state policy being developed. The following were some of the suggestions made by our senior members:

- Monthly financial assistance should be given to the Senior Citizens based on their age and needs. A suggested pattern of payment could be as under:
 - 60 to 69 years:₹5k
 - 70 to 79 years: ₹10k
 - 80 years & above: ₹15k
- 2. For windows and disabled persons, the above amounts must be doubled. Also, the above amounts should be automatically increased by 5% every year.

- 3. Eligibility, enumeration, application form, etc. should be simplified and brought into e-Governance and e-Seva Centres.
- All social security schemes for Senior Citizens should be totally managed by the Social Welfare Department.
- 5. Government of Tamilnadu should establish a separate department (like in Telungana and other states) to take care of Senior Citizens and Differently Abled persons, as there is a substantial increase in the population of Senior Citizens in Tamilnadu from 75 lakhs (in 2011) to 1.5 crores in 2021.
- 6. According to the Ministry of Social Justice and Empowerment, Government of India, there are 10 social security schemes for Senior Citizens. Under of some of these schemes (particularly Senior Citizens Welfare Fund), sizeable resources are available from Institutions like the courts. Better transparency to the public about the receipts and payments under these special schemes would be welcome.
- 7. Also, a mandatory 0.5% allocation to Senior Citizens under Corporate Social Responsibility was suggested.
- 8. It was suggested that social security schemes should promote viable social security institutions for providing universal social protection through world class services. Social security schemes should aim to improve the quality of life of Senior Citizens through an integrated program providing psychological counselling, guidance, and assistance.

We appreciate that the desire of the Government to develop a good policy for the Senior Citizens in Tamilnadu. We trust and hope that the Honourable Ministers of Social Welfare and Women Empowerment will present the policy before end of December.
